#### State and National


- NAHB Build Pac is donating to Congressman Langworthy and Rick Herman is going to set up a meeting in his office to present a donation to him.
- Building Codes Council will be meeting Sept 27th and the Sprinkler study that was done for single households will be released. They are also working on a wetlands study.








